

Clark County School District 2025–2026 Assembly Bill 195 Requirements

Assembly Bill 195 Overview

[Assembly Bill \(AB\) 195](#) revises provisions relating to pupils who are English learners (ELs), extending the rights of EL pupils and parents/guardians. Section 3 of the bill provides an overview of the rights. Additionally, school districts are required to collect and report data concerning ELs, aiming to enhance transparency and accountability in the provision of education to these students. Schools support the implementation of AB 195 by verifying the posting of EL pupil and parent/guardian rights in the fall of each year and by reporting EL participation in athletics and extracurricular activities in the spring of each year.

Verification of Posting of EL Pupil and Parent/Guardian Rights

By the deadline of Friday, August 1, 2025, all Clark County School District (District) public and charter schools that enroll ELs are required to post a copy of the rights described in AB 195 on their school websites in as many languages as possible, reflective of their student population. Available translations are provided on the [English Language Learner Division \(ELLD\)](#) website.

Principals must verify that the rights have been posted to their website by submitting a link to their school webpage, under the Parents tab, via the [AB 195 2025–2026 Verification of Posting of English Learner Pupil and Parent/Guardian Rights Form](#).

Spring Required Data Reporting: EL Athletics and Extracurricular Activities Participation

All secondary school sites must report data for EL participation in athletics and extracurricular activities using the [AB 195 2025–2026 Athletics and Extracurricular Activities Participation Form](#) no later than Friday, May 1, 2026. Principals should work with athletic and activity directors at each secondary school to provide the number of ELs by grade level who participated in one or more of the following sports or extracurricular activities during the 2025–2026 school year. If an EL student participated in more than one sport or extracurricular activity, the student should be counted only once. Requests for the [AB 195 2025–2026 Athletics and Extracurricular Activities Participation Form](#) will be sent in April 2026.

Grades 6–8

- Athletics: Flag Football, Soccer, Basketball, or Volleyball
- Activities: Band, Chorus, Newspaper, Human Relations, Speech and Debate, Yearbook, Orchestra, Cheerleader, Dance/Drill Team, Drama, Chess Club/Chess, Honor Society, Student Council, Mariachi/Guitar, or JV Quiz

Grades 9–12

- Athletics: Any Nevada Interscholastic Activities Association (NIAA) sanctioned sport
- Activities: Band, Chorus, Mariachi/Guitar, Yearbook, Drama/Theatre, Newspaper, Pep Club, Cheerleader, Speech and Debate Club, Dance/Drill Team, Student Council, Key Club, Human Relations, Varsity Quiz, Orchestra, Chess Club, Future Business Leaders of America (FBLA), Honor Society, Reserve Officers' Training Corps (ROTC), Distributive

Education Clubs of America (DECA), Vocational Industrial Clubs of America (VICA), or Family, Career and Community Leaders of America (FCCLA)
